



EVENT: 51st Annual Green Lake Fine Art Show presented by Town Square Community Center

Date and Time: Saturday, August 10, 2024, 10-5 pm & Sunday, August 11, 2024, 10-3 pm.

ELIGIBILITY

All works must be original in concept and design and must have been executed by the applicant's work from molds or kits, commercial or manufactured items, and mass-produced items are not permitted. Media is limited to Fine Art/Fine Craft in the categories listed.

ENTRY FEES

1. A non-refundable application fee of \$25 must be submitted with registration forms due by midnight, March 15, 2024.
2. A required \$175 fee for a 10'x10' space, (or \$350 for 10'x20' space) is the second check you are required to submit. This will be returned if not accepted for the show.
3. There will be no refunds for cancellations after May 31, 2024.

Media: Artists may exhibit and sell their art, provided that each piece of work is of original artisanship by the artist exhibiting. We are seeking originality, a professional booth display, and handcrafted fine art of the highest quality. We do not accept commercially made items. Work that has been made with the use of commercial kits, molds, patterns, stencils, or prefabricated forms will not be accepted. The art show committee reserves the right to reject any entry or exhibit that does not comply with these guidelines.

Reproductions: Only original work may be exhibited.

Exhibition: Each artist will be responsible for preparing, exhibiting, setup, and takedown of their work, and collecting the 5.5% Wisconsin Sales tax. Spaces are preassigned and non transferable. A 10'x10' booth space is provided. Only 1 medium per booth space is allowed. *Information on setup time, parking and more will be included with the acceptance letter.*

Booth Fee: This is a juried show. Application fee is \$25, processed when the application is received. Booth space fees will be processed at the time you are notified that you have been accepted. ***The application fee and booth fee are separate checks.*** Town Square does not take a commission on sales. One artist, one media per booth.

How to Apply: Complete and return the application with 2 checks payable to Town Square or credit card information.

SUBMISSION OF ENTRIES

All participants will be juried using digital JPEG images. A total of five digital images must be submitted: **FOUR** images must be of your current work and **ONE** of your booth showing items displayed. Digital images must be high quality JPEGs, limit size to 1MB, images exceeding this size limit will not be considered. Submit all images online.

1. Email your images to: artshow@greenlaketownsquare.org. Include your name and media in the subject line of your email.

Upload Size Options for Image Files:

- File Format: JPEG Only
- File Dimensions: No smaller than 500 pixels on the longest side
- File Resolution: 72 ppi/dpi (standard web resolution)
- File Size: 1 MB (maximum) Files exceeding this size will not be considered.

If mailing your application, make an 8 ½" x 11" reference sheet representing the BOOTH image and FOUR images of the artwork submitted. This must be mailed to our office with your application and fees. Mail to: Town Square, PO Box 608, Green Lake WI 54941.

Compliance: Photos MUST be representative of the work to be sold. The Art Show Committee will refuse the exhibition of work that is not consistent with submitted photos or show rules. By completing the application to participate in the art show, you, the artist, certify that all work is in strict conformity with the rules of eligibility. The art show committee is the sole arbiter of any dispute, and the decision of the committee is final and binding

Important Dates: Entry deadline is March 15, 2024. The committee will notify applicants of acceptance by April 15, 2024. A formal letter or email will follow.

Loss/Damage: Artists are responsible for their own product/contents. It is the responsibility of the artist to insure and keep the area you are occupying for this event. Town Square/Green Lake Renewal is not insured to cover your property or contents within your booth space. By signing this application, you agree that Town Square/Green Lake Renewal will not be liable for loss or damage of artwork or display material.

Rain Arrangements: There is no alternative indoor location. Each artist is responsible for providing his/her own protection from the elements for themselves, the work and display material. Unfortunately, registration money cannot be refunded because of undesirable weather.

Balance of Media: The Green Lake Fine Art Show limits the number of booths per media type to ensure a well-rounded show. Some categories fill up quickly, so we encourage you to apply early.

Jury Process: Selection will be made based on artisanship, originality, and creativity. If the application is declined your booth fee will be returned.

Awards: All artists with work on exhibit will be eligible for a ribbon award and a cash prize.

- Best of Show - \$1,000
- Award of Excellence - \$500
- Honorable Mention(2) - \$250
